This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

Qaraah Films does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Qaraah Films may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. - as necessary to maintain, safeguard and preserve all the rights and property of Qaraah Films.

Notice to European Union Users
